#### 1. Unterverwahrung nach § 82 KAGB

##### 1.1 Darstellung

Die Hamburger Sparkasse AG als Verwahrstelle für Alternative Investmentfonds (AIF) nimmt für die Verwahrung der Wertpapiere der AIF die Dienstleistungen der Deutsche Wertpapier Service Bank AG, Frankfurt in Anspruch. Diese Verwahrt die Wertpapiere über die deutschen Wertpapiersammelbank Clearstream Banking AG, Frankfurt. Für ausländische Wertpapiere bedient sich die Clearstream Banking AG wiederum der Dienstleistungen der Clearstream Banking S.A., Luxembourg und deren Lagerstellennetzwerk. Das bei Auflage des AIF aktuelle Lagerstellennetzwerk ist im Folgenden dargestellt. Es kann sich allerdings jederzeit ändern. Gegebenenfalls werden auch nicht sämtliche dieser Lagerstellen für den AIF genutzt.

Die Unterverwahrung von Anteilen an Investmentfonds, die aufgrund der Emissionsbedingungen ausschließlich bei den benannten Registraren im Anteilregister geführt werden können, erfolgt bei diesen Registraren, soweit die Hamburger Sparkasse in das Register eingetragen wird.
